

# Santa's Charity Fun Run



## Terms & Conditions

Santa's Charity Fun Run, Jog or Walk is an enjoyable event but we want it to be safe too! Please read these Terms & Conditions carefully and make sure you tick the box on the Registration Form to say you understand and accept them. They apply to all entrants.

### Definitions

The following Definitions are used in these Terms & Conditions:

“the event”: means Santa's Charity Fun Run, Jog or Walk.

“we”, “us”, “Channel Rotary”: means The Rotary Club of Folkestone Channel.

“you” “your”: means the person entering Santa's Charity Fun Run, Jog or Walk.

“marshal”: means any designated event official authorised by us.

“vehicle”: means any wheelchair, pram, pushchair or similar transport device propelled by human power.

### Fancy Dress

In the spirit of Christmas you will wear your Santa suit or other seasonal fancy dress at all times during the event and understand that you cannot win unless you do.

### Charities and Sponsorship

The event is organised by Channel Rotary to raise money for deserving causes. You therefore agree to:

give all sponsorship money to us unless you have told us in writing before the event that you wish to donate up to 50% of your sponsorship to your own designated charity. If you have split your sponsorship, you must pass money to any other charities than Channel Rotary's Santa Fund yourself. We cannot do this for you.

ensure that your Sponsorship Form is correctly completed with your sponsors' details so that Gift Aid may be recovered from HM Revenue & Customs. where possible, give your Sponsorship Form and money to Channel Rotary on the day so we can distribute much needed funds as quickly as possible.

### Age Categories

You must be at least 12 years old to enter as an adult participant and at least 6 years old to enter as a child participant. Child entrants must be under the full control of a parent, guardian, teacher or similar responsible person who will be solely accountable for them throughout the event.

### Health and Conduct

Although there is no upper age limit, you accept that you are responsible for your own well-being. You therefore undertake that you are participating at your own risk and that you will only take part if you are of sound fitness and are able to safely complete the course in the designated time period of 11.30 to 1pm without causing a danger to yourself or others. We reserve the right to remove you from the course if we reasonably believe that your health could be at risk or that you are a danger to others.

### Registration Fee

You must pay your Registration Fee before entering the event. You may do this in advance:

by downloading a Registration Form from the website and sending the completed form with your Fee (cheques payable to 'Channel Rotary') to The Santa Office, c/o Lee Robinson, The Courtyard, Evegate Business Centre, Station Road, Smeeth, Kent. TN25 6SX on the day at the Registration Point, provided you do so before 11am.

As for all events, we use your Registration Fee to pay pre-event expenses and provide facilities on the day. Therefore, we will not be able to refund it even if the event has to be cancelled (eg. due to bad weather).

### Vehicles

You must accompany your Run vehicle at all times. If you leave it unattended you do so at your own risk and we accept no liability for any loss or damage. It is your sole responsibility to ensure that your vehicle is safe to use.

### Your Run Number

You must plainly display your Run Number at all times and maintain it in an unaltered, unobstructed and readable state from Start to Finish of the course.

### The Course

You are responsible for:

following the designated course. Please familiarize yourself with it beforehand.

obeying all relevant traffic laws and codes and instructions of Marshals.

### Mobile Phones

We strongly recommend that you carry a mobile phone in case of emergency.
